We welcome abstract submissions that engage with (but are not limited to) the following areas:

- Ethical Culture: Shared values and practices that promote ethical behaviour
- Performance: Sustainable value creation in an economic, social and environmental context
- Conformance: Regulatory discipline and internal control systems
- Legitimacy: Trust, reputation and responsible citizenship

Abstracts should be 750–1 000 words and follow this structure:

- Purpose
- Design/methodology/approach
- Findings/results
- Originality/contribution

Note that although abstracts will not be published, a conference booklet with presentation titles, author details, and a 100-word summary will be shared.

All submissions should include a title, 5–8 keywords, in-text references, and a reference list (the reference list is *excluded* from the word count). Additionally, submit a 75–100-word summary (no headings) for inclusion in the conference booklet. All submissions will undergo a blind peer review process.

The conference is supported by several South African and international journals. Details will follow soon
